



Green Cleaning Statement

Willington Public Schools, in compliance with the requirements of the State of Connecticut Public Act No. 09-81 regarding green cleaning products in schools, is providing this information on the green cleaning products used in our facilities.

Our ongoing Green Cleaning Program continues to reduce the exposure to building occupants from potentially hazardous products, equipment or procedures which could adversely affect human health and the environment, indoors and outdoors.

The components of our Green Cleaning Program as required by Connecticut Public Act No. 09-81 include:

- A description and names of environmentally preferable cleaning products being used in the schools.
- The location and application of where cleaning products are used.
- The schedule or frequency of when such cleaning products are applied.
- Eliminate and monitor cleaning products being brought in from outside unauthorized sources as required by Connecticut Public Act No. 09-81 "No parent, guardian, teacher or staff member may bring into the school facility any consumer product which is intended to clean, deodorize, sanitize or disinfect."
- The name of the designee who may be contacted for further information will be provided.

Description & Product Names of Environmentally Preferable Green Seal Cleaning Products

Willington Public Schools utilize the **Hillyard Arsenal One Dispenser System** to ensure proper dilution ratios of our green cleaning chemicals. Dispensers are distributed throughout both schools in secured custodial closets.

Hillyard Green Select Glass Cleaner #27	Glass Cleaner	All glass surfaces	Nightly and as needed during school hours
Hillyard Green Select Stripper	Used to remove old wax from floors	All waxed floors	Non school days.
Hillyard EP-22	Floor finish	All waxed floors	Non school days.

We will also conduct scheduled training for our custodial staff to insure that they are trained properly and are knowledgeable in the proper and safe use of the cleaning products and equipment used in our school facilities.

We will strive to remain vigilant of ongoing changes in laws, cleaning techniques and cost effective products that may affect and improve our Green Cleaning Program.

Our intent is to make certain we remain in compliance with Connecticut Public Act No. 09-81 and that our custodial staff continues to provide our students, teachers and staff with a safe and clean environment.
